BC Dairy Quota Policy & Governance Consultation Update

The Board initiated a Quota Policy & Governance Consultation in the spring of 2013 with the support of the BC Farm Industry Review Board (BCFIRB) that will be used to develop an effective long term quota allocation and governance policy.

During the period of September 26 –October 10, 2013 consultation sessions were held to discuss BC Quota Policy & Governance. The sessions were held in the following regions in British Columbia – Vancouver Island (Nanaimo), Fraser Valley (Abbotsford), Bulkley Valley (Smithers), Cariboo & Peace River (Prince George), Fraser Valley (Chilliwack), Okanagan (Salmon Arm) and Kootenays (Creston).

The participation and dialogue during these sessions was impressive with a total number of 229 in attendance to provide input on current quota policies and insight for the development of future policy.

The Board completed Stage 1 of the consultation "Identifying Issues and Ideas" at the fall producer meeting held in Vancouver on November 29, 2013. The summary provided included key themes that surfaced through the face to face sessions and any written comments within scope of the consultation.

The Board is currently in the process of Stage 2 of the consultation "Finding Solutions" from producers and the dairy industry input with respect to quota policy and will release a paper in early January outlining the quota policy considerations that surfaced from the analysis stage of the consultation.

The Board is requesting comments from the industry with respect to the quota policies that will be outlined in the January 2014 discussion paper. The deadline for submission will be January 31st, 2014.

In addition to comments from the industry, the Board will engage in discussions with the BC Dairy Association (BCDA), the regional producer associations, the Quota Exchange Committee (QEC), and the Milk Industry Advisory Committee (MIAC) to ensure all policy considerations have been discussed.

Following these discussions the Board will submit a paper to the Farm Industry Review Board (FIRB) addressing all quota policies in the BC dairy industry. This paper will be posted online following the submission and highlights will be presented at the spring producer meetings.

The Board thanks you for your participation during this consultation to date and encourages your continued participation.
