

Producer Component Prices and Standard Blend

The producer component prices for the month of August are as follows: BF= \$10.5809, PR= \$9.0207, OS= \$1.8766 or an equivalent return of \$77.9202 per standard hectolitre. This return compares to \$78.3063 in June 2014, with a difference of -\$0.3861/std.hL. The P10/WMP equalization transfer for the month of August was \$1,002,488.54. Notice to Industry – Amending Order Final Consultation – September 4, 2014

On September 3, 2014, the Board *conditionally approved* a draft Amending Order for the *Code of Practice for the Care and Handling of Dairy Cattle* to become mandatory within the Board's Consolidated Order. An Industry Notice was issued September 4, 2014 for a two week final consultation. The Board is expecting to determine its final approval on the Amending Order at the September 24, 2014 Board meeting (with an effective date of October 1, 2014). The Industry Notice, which includes more detail and a copy of the draft Amending Order are posted on the BCMMB website.
